- \_ 1" Left, Right, Top and Bottom Margins
- \_ Avoid use of excessive underlining, italicizing or bullet points
- \_ No use of all capital letters or bolded text for emphasis. No charts, graphs or images
- \_ 14,000 Words and 70 Page Limit
- \_ No Addendum
- \_ Submit Brief no later than 11:00 AM on Filing Day to Ensure Prompt Filing and E-Filing

- \_ \$315.00 Filing Fee (Payable to Appellate Division–First Department)
- \_ Note of Issue
- \_ Personal service is required on last day to perfect appeal or file for a particular court term.
